
BY-LAW NUMBER 18-2012

**A BY-LAW TO AMEND THE BY-LAW ADOPTING A
PLAN OF COUNTY ROAD IMPROVEMENT AND
ESTABLISHING A COUNTY ROAD SYSTEM IN
THE COUNTY OF ESSEX, UNDER THE PUBLIC
TRANSPORTATION AND HIGHWAY
IMPROVEMENT ACT**


Pursuant to Subsections 44(5) and 44(6) of the Public Transportation and Highway Improvement Act, R.S.O. 1990, Chapter P.50, the Council of the Corporation of the County of Essex enacts as follows:

1. The schedule of the Consolidating By-Law Number 2558, as amended by By-law Numbers 2587, 2960, 3268-97, 3308-97, 3349-98, 48-99, 09-2000, 42-2001, and 37-2002 is further amended by:
 - (a) Removing therefrom Plan Numbered 20-1-98.
 - (b) Adding thereto Plan Numbered 33-1-12 attached hereto of a road to be known as County Road 33.
 - (c) Removing therefrom Plan Numbered 37-1 and adding thereto Plan Numbered 37-2-12 attached hereto of a road known as County Road 37.
2. That this By-law shall come into force and take effect on the 1st day of April 2012.

3rd reading - March 21st, 2012
