# 1. Spring Training

Guest Speakers: Deputy Chief Justin Lammers and Captain Stacey Shepley, Professional Standards

Spring Training this year will have a focus on Mass Casualty Incidents. We have been working with Allied Agencies to better understand our role at standby's with Incident Command. In an Active Assailant situation, EWEMS will be in the warm zone, not the hot zone.

SPRT process will be used. Body armour may need to be considered. The JHSC will need to look into options.

**ACTION**: Add to next agenda to task 2 people to investigate options.

#### 2. Overspeed Presentation

Overspeed alerts were set at 130 km/hr. The alert goes to Justin. The alerts were not catching overlimit speeding ex. 100 km/hr in a 50km/hr zone. So 40 km/hr over the posted limit was turned on as well. More alerts began to come in. When an alert is received an IR is requested and conversations are had from there.

The review included investigating incidents of 130 km/hr or 40 km/hr over for 5 seconds. How is best to monitor this?

Step 1 will be to educate staff on the dangers / risks of speeding. Driver education is being planned for the Spring to review abilities and educate.

# 6. COE Health and Safety Advisory Group Update

COE is hiring a Health & Safety Consultant. All departments will have the same manual with areas of specialty for departments as needed. It will be housed on the County website.

# 7. Idling trucks at hospitals

This topic is more of a concern during the winter months when trucks are more likely to be idling for longer periods. CO filters into the buildings. Refrain from idling under canopies at hospitals.

# 8. Tecumseh Base – allergen concerns

Tyson inspected drains and traps and did find any mold anywhere. Men's washroom reportedly as smelling musty but no issues were found. Under the lockers were inspected and no issues were found in this area either. There have been no concerns presented since the initial complaint.

#### 9. Tampering with Exhaust fans in the garages

Jefferson exhaust fan override was being tampered with. JHSC members are asked to keep an eye out for this. If you notice they run constantly, then report it. They should only run for 4 minutes.

#### 10. H&S manual update

Continue with our update while we wait for the COE.

## 11. Canvas and Poles - discussion about safety

It is the preference of the crew on which device fits the situation. There is no standard to dictate which piece is used when.

#### 12. PPE and Hairstyles

Ponytails down to the middle of the back or waist length could be an entanglement risk. Policy PP170 states that hair must be suitably confined to prevent entanglement. All side support asking staff to pull their hair up. All members are asked to help support this issue by educating.
