I would like to have the opportunity to explain our request for some of the Cat Spay and Neuter Vouchers to have the EARTIP ONLY requirement removed. Not all the vouchers, just a few, whatever you see fit to offer our group.

We have been providing a service to the Town of Amherstburg on strictly a volunteer basis. Helping neighbourhoods and individuals with lost, stray, free roaming and feral cats and kittens. When called about a litter of kittens, we trap, secure them, bring them into foster, tame them, spay/nueter and find them a forever loving home. This incurs expenses for food, litter and vet care. Additionally, there is the original expenses of purchasing traps and necessary baits. The adult cats in the neighbourhood are also trapped, TNR'd (eartipped) and returned to their oringinal location.

We completely agree with eartipping these feral cats that live in colonies and are not homeable. Eartipping is a very important part of TNR and rescue. What we are asking for is that some of these unused vouchers have the stipulation of mandatory eartip removed, so that our group could use them in our rescuing of these kittens. Last year alone we rescued 46 kittens that, had we not rescued from the streets, would currently be in a colony reproducing. This would produce hundreds more. We also rescued 10 lost, stray, freindly adult cats. We brought them into the vets to search for microchips hoping to find their owners. We then posted them on local

social media looking for their owners. When no one came forward we proceded to vet the cats, spay/nueter and find them forever homes. These cats were never eartipped as we find that people do not like to adopt an eartipped cat.

It's mentioned in the recommendation that the Windsor Essex Humane Society was consulted for advice. We follow their same protocal. Adoptible cats are not eartipped.

You will also find, if you check the returned vouchers, that our group used approx. 19 of them. These cats were all feral, spay/neutered, eartipped and returned to their caregivers and colonies.

Our request, if possible, is that The Amherstburg Cat Support Crew receive some of the vouchers, with the mandatory eartip requirement removed. These vouchers are already allocated in the budget. History shows that there were 111 vouchers not all being utilized. These vouchers will be used to help offset our substantial costs of rescueing these unaltered cats from the streets of Amhertsburg, and preventing the birth of hundreds more.
