## CORPORATION OF THE TOWN OF AMHERSTBURG BY-LAW NO. 1998-53

Being a by-law to establish a water service rate

WHEREAS authority to regulate the distribution and use of water and to establish rates for its' customers is provided under the Public Utilities Act, Section 8, R.S.O. 1990 as amended;

AND WHEREAS the Town of Amherstburg has recommended a rate sufficient to defray its' expenditures for the operation of its' works;

## NOW THEREFORE BE IT ENACTED BY THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG AS FOLLOWS:

1) The rate for water consumers of the Town of Amherstburg shall be as follows:

- 3) By-law number 1998-46 is hereby repealed.
