

**CORPORATION OF THE TOWN OF AMHERSTBURG**

**BY-LAW NO. 1999-63**

A By-law to authorize the construction of a 2" watermain on the 6<sup>th</sup> Concession between County Road 18 and the Anderdon Malden Townline.

**WHEREAS** Mr. Ronald Wismer has petitioned a two inch watermain from County Road 18 to serve his property fronting on the 6<sup>th</sup> Concession.

**AND WHEREAS** Mr. John D'Angelo and Mr. Albert Larabee have petitioned for a 2" watermain from the Anderdon Malden Townline to serve their properties fronting on the 6<sup>th</sup> Concession.

**AND WHEREAS** the Town of Amherstburg is agreeable to constructing the remainder of the 2" main (APPROXIMATELY 900'-1000') required to interconnect the two proposed lines.

**AND WHEREAS** the Municipal Act R.S.O. 1990 Section 210(58) and Section 221 and amendments thereto authorize a municipality to construct a waterworks system including the necessary watermains, private service connections and appurtenances and to create water consuming areas as an improvement and extension to the Corporation's present water supply system.

**AND WHEREAS** the Corporation is agreeable with E. Bondy Enterprises Ltd. performing the installation of the watermains.

**NOW THEREFORE THE CORPORATION OF THE**

**TOWN OF AMHERSTBURG ENACTS AS FOLLOWS:**

1. That the Town authorize E. Bondy Enterprises Ltd. to construct a 2" watermain on the 6<sup>th</sup> Concession between County Road 18 and the Anderdon Malden Townline.
2. That the lands fronting on the work are hereby declared to be an area and the costs are to be divided as follows:


From County Road 18 to the Wismer property (Concession 5 Pt Lot 44 Pt Lot 45) the cost is to be paid directly to E. Bondy Enterprise by Mr. R. Wismer and Mr. J. Meloche. Cost of Engineering from Hanna Ghobrial & Spencer and Supervisor, testing, etc. by Town Staff to be paid to the Town by Mr. Wismer and Mr. Meloche.

From Anderdon Malden Townline to the Larabee property (Concession 6 Pt Lot 76) the cost is to be paid directly to E. Bondy Enterprise by Mr. Larabee and Mr. D'Angelo or at the option of Mr. Larabee and Mr. D'Angelo the Town will pay E. Bondy Enterprises and finance the amount through sale of debentures and place the annual debenture charge on the taxes of Mr. Larabee and Mr. D'Angelo. Cost of Engineering from Hanna Ghobrial & Spencer and supervision, testing, etc, by Town staff to be paid by Mr. Larabee and Mr. D'Angelo.

The cost of interconnecting the two above lines (approximately 900'-1000') will be borne by the Town of Amherstburg Water Department.

3. That other properties desirous of connecting to this watermain in the future will require approval of the Town and may be subject to a frontage and connection charge and any other charges or rates that may be in effect at that time.

4. That this by-law shall come into force and take effect upon the final passing thereof.
