CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2003-54

Being a by-law to repeal By-law 2002-38.

WHEREAS the Council of the Town of Amherstburg passed By-law 2002-38 on the 23rd day of September, 2002 being a by-law to authorize the execution of an Amending Agreement;

AND WHEREAS this agreement amended a Subdivision Agreement dated August 22, 1997 for a residential development known as Golfview Park Estates;

AND WHEREAS the developers of the lands affected by the August 22, 1997 agreement were granted approval for 165 lots and were willing to freeze 31 of those lots for which sewage allocation had been granted in exchange for approval of 34 townhome units within the lands to the east;

AND WHEREAS the Ministry of Municipal Affairs and Housing will not grant final approval of the draft plan for Phase 2 which includes the lands for the townhome site for which allocation was intended;

AND WHEREAS the Developer has requested to continue with the development of Phase 1, Plan 12M-394;

AND WHEREAS the Developer has requested that By-law 2002-38 be repealed;

NOW THEREFORE THE MUNICIPAL COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

- (1) That By-law 2002-38 be and is hereby repealed.
- (2) That this By-law be registered against the title to the lands as described in Schedule "A" hereto.
- (3) That this By-law shall come into force and take effect on the date of final passage.

Read a first, second and third time and finally passed this 14th day of July, 2003.
