# THE CORPORATION OF THE TOWN OF AMHERSTBURG <br> BY-LAW NO. 2003-56 

Being a By-law to Allocate the Costs of a<br>Waterman to Benefiting Landowners

WHEREAS Council of the Town of Amherstburg authorized the construction of an 8 " waterman on Alma Street from Meloche Road to the $4^{\text {th }}$ Concession South; and

WHEREAS the firm of Hanna Ghobrial Spencer prepared the necessary specifications, advertised for tenders and provided supervision and inspection of the said watermain; and

WHEREAS D'Amore Construction was awarded the contract for the project along with a Sanitary Sewer on a portion of Alma Street and the replacing of a watermain and the construction of a storm sewer on portions of Victoria Street; and

WHEREAS the cost of the Alma Street Waterline portion of the tender price is $\mathbf{\$ 2 8 6 , 1 2 8 . 6 0}$ including engineering fees and interim financing; and

WHEREAS the Town has considered a portion of the project to be looping to better the existing system; and

WHEREAS the amount attributed to looping is calculated to be $\$ 61,825.73$ which leaves a balance of $\$ 224,302.87$; and

WHEREAS the Town has decided that further reductions should be made for the cost of the oversizing of the main and the equivalent cost that would have been allocated to the five dwelling units that had previously paid into a system; and

WHEREAS the Town is desirous of charging the balance of $\$ 190,261.83$ as outlined in a letter from Hanna Ghobrial \& Spencer dated June $24^{\text {th }}, 2003$ to the Town, at a rate of $\$ 24.29$ per foot frontage to the eligible properties on both the North side and South side of Alma Street between Meloche Road and the $4^{\text {th }}$ Concession South

## NOW THEREFORE THE CORPORATION OF THE TOWN OF AMHERSTBURG ENACTS AS FOLLOWS:

1. That the eligible properties fronting on the North and South side of Alma Street between Meloche Road and $4^{\text {th }}$ Concession South be assessed for the 8 " waterline at time of application for connection in accordance with Schedule "A" attached to and forming part of this Bylaw.
2. Owners of eligible assessable properties shall have the following options:
(a) pay the rates shown in Schedule " A " at the time of the passing of the By-Law
(b) pay at time of connection - amount shown in Schedule "A"
(c) at time of connection the property owner has the option of financing over a 5 year period the amount shown in Schedule "A"
3. That in the event a severance or severances are obtained, the per foot frontage charge shall be applicable to the footage for the severed lot and the footage for the retained lot shall be reduced by an equivalent amount. Payment options as set out in \# 2 (a)(b)(c) above apply.
4. That the properties on the North and South side of Alma Street between Meloche Road and $4^{\text {th }}$ Concession South become part of the Amherstburg Water Service Area.
