#### BY-LAW NO. 2003-96

### Being a By-law to strike taxes from the Tax Roll.

- Assessment Review Board Decisions or Minutes of Settlement. 2.
- 3. Charitable Rebates under provisions of Essex County By-Law number 15-2001.
- Royal Canadian Legion Rebate under provisions of Essex County By-Law number 16-2001. 4.

And Whereas the Council has recommended that the said taxes be struck from the Tax Roll.

### NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:
