

THE CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2004-50

Being a By-law to strike taxes from the Tax Roll.

Whereas the Tax Collector of the Corporation of the Town of Amherstburg has recommended to the Municipal Council that the Taxes set forth in Schedule "A" attached hereto be struck from the Tax Roll due to one or more of the following:

1. Applications under Sections 354(1,2), 357, 361, 362, 365, or 358 of the Municipal Act, R.S.O. 2001, Ch.25 and Applications under Sections 442 and 443 of the Municipal Act R.S.O. 1990.
2. Assessment Review Board Decisions or Minutes of Settlement.
3. Uncollectible

And Whereas the Council has recommended that the said taxes be struck from the Tax Roll.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

1. The Tax Collector is hereby authorized and instructed to strike from the Tax Roll those taxes set forth in **Schedule "A" attached hereto and declared to be a part of this By-law.**
2. This By-law shall take effect on the final date of passing thereof.

READ a third time and finally passed this 28th day of June 2004.
