BY-LAW NO. 2004-73

Being a By-law to dedicate as part of the Town Highway System reserve blocks in a portion of the Kingsbridge Subdivision

WHEREAS under the terms of subdivision agreements relating to various subdivisions, reserve blocks, laid out as part of the street system in the subdivisions, were reserved by the developer, and were not to be accepted and dedicated by the Town of Amherstburg until all of the requirements of the developer had been met;

AND WHEREAS the developer has completed all of the servicing to which the reserve blocks herein referred to relates, those services have all been initially or finally accepted by the Town of Amherstburg, and the developer has requested that the reserve blocks be accepted and dedicated to remove any question of the rights of access by owners of lots in those serviced phases of the subdivision.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF

THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

- 1. The following lands, earlier conveyed to the Town, all be, and the same are hereby assumed for public use as a public highway:
 - a. Block 95 (Reserve), Plan 12M-441;
 - b. Block 96 (Reserve), Plan 12M-441;
 - c. Block 97 (Reserve), Plan 12M-441;
 - d. Block 98 (Reserve), Plan 12M-441;
 - e. Block 99 (Reserve), Plan 12M-441;
 - f. Block 100 (Reserve), Plan 12M-441.
- 2. This By-law shall come into force and take effect after the final passing thereof on the day upon which it is registered in the Land Registry Office for the Land Titles Division of Essex (No. 12).
