**BEING A BY-LAW TO AMEND BY-LAW NO. 2002-05,
AS PREVIOUSLY AMENDED BY BY-LAW 2002-37,
“A BY-LAW IMPOSING SPECIAL ANNUAL RATES
UPON LAND IN RESPECT OF WHICH MONEY IS
BORROWED UNDER THE SHORELINE PROPERTY
ASSISTANCE ACT.”**


WHEREAS the Council of the Town of Amherstburg deems it appropriate to amend By-Law No. 2002-05;


AND WHEREAS By-Law No. 2002-05 section 2 allows amendments to the Schedule should an owner obtain a discharge of indebtedness under Section 12 of the said Act in respect of land described in the attached Schedule;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION
OF THE TOWN OF AMHERSTBURG ENACTS AS FOLLOWS:**

1. THAT Section 1 of By-Law No. 2002-05 be revoked and amended with the following:
 1. The annual rates as set out in the revised Schedule “A” (REV02) attached hereto are, subject to the provisions of this by-law, hereby imposed upon such land as described for a period of ten years, such rates to be levied and collected in the same manner as taxes.
2. This By-law comes into force and effect upon final passing hereof.
