

THE CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2005-20

Being a By-law to designate Community Safety Zones
in the Town of Amherstburg

WHEREAS, Section 214.1 of the *Highway Traffic Act, R.S.O. 1990, c.H.8.*, provides the Council of a municipality authority to designate community safety zones on parts of highways under its jurisdiction if, in the Council's opinion, public safety is of special concern on that part of the highway;

AND WHEREAS it is deemed expedient by Council to pass such a by-law within the Town of Amherstburg for the purposes of public safety;

**NOW THEREFORE THE COUNCIL OF THE CORPORATION OF
THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:**

1. DEFINITIONS:

In this By-law:

- a) "Community Safety Zone" means a highway or part of a highway where public safety is of special concern, fines have been increased for certain traffic violations and that is identified by "community safety zone" official signs as prescribed in regulations under the *Highway Traffic Act*;
- b) "Highway" means a highway as defined in the *Highway Traffic Act* of Ontario, Chapter H.8 1990 as amended from time to time;


2. APPLICATION:

- a) The Highways set out in Columns 1 and limits as defined in Columns 2 and 3 of Schedule "A" shall be designated as Community Safety Zones during the prohibited times or days as set out in Column 4 to the said Schedule "A".
- b) This by-law shall become effective when signs are erected, in accordance with the *Highway Traffic Act* and the regulations, on the designated part of the highway.


3. SCHEDULE:

Schedule "A" attached hereto forms part of this By-law.
