#### THE CORPORATION OF THE TOWN OF AMHERSTBURG

#### **BY-LAW NO. 2005-24**

Being a By-law to prohibit or regulate certain animals within the Town of Amherstburg

WHEREAS, the *Municipal Act*, 2001, S.O. 2001, c. 25, section 11(1), paragraph 9, permits councils of local municipalities to pass by-laws for the prohibiting or regulating of animals and to provide for a system of licences, permits, approvals or registrations respecting animals and imposing conditions as a requirement of obtaining, continuing to hold or renewing a licence, permit, approval or registration;

**AND WHEREAS** the Town of Amherstburg considers it desirable to pass a by-law to prohibit or regulate certain animals within the limits of the municipality of the Town of Amherstburg;

# NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

## 1. **DEFINITIONS**:

In this By-law:

- a) "Animal" means any live non-human vertebrate or invertebrate including insects, birds and reptiles;
- b) "Animal Control Officer" includes the person appointed by Council or who has entered into a contract with the Town of Amherstburg to control animals under this by-law and includes any servants of such person;
- c) "Corporation" means the Corporation of the Town of Amherstburg;
- d) "Council" means the municipal council of the Town of Amherstburg;
- e) "Owner" includes a person who possesses or harbours an animal, and, for the purpose of this definition, "owns" and "owned" shall have a corresponding meaning and shall include a person who is temporarily the keeper or in control of the animal;
- f) "Person" includes any individual, corporation, partnership, company, association or party and the heirs, executors, administrators, or other legal representative of such person, to whom the context can apply according to law; shall include any group of persons comprising a society or other organization and shall include the plural wherein the context requires;
- g) "Pound" means premises, regulated under the *Animals for Research Act*, R.S.O. 1990, c.A.22, that are used for confinement, maintenance or disposal of dogs that have to be impounded pursuant to applicable law;
- h) "Pound keeper" means the person appointed by the Corporation to maintain and administer the pound;
- i) "Prohibited Animal" means any animal listed in Schedule "A" to this bylaw:
- j) "Provincial Offences Officer" means a police officer or a person designated under the *Provincial Offences Act* and for the purposes of this

by-law includes an animal control officer and any municipal By-Law Enforcement Officer engaged to enforce the by-laws of the Town of Amherstburg;

k) "Town" means the Town of Amherstburg.

## 2. PROHIBITION:

- a) No person shall possess, keep, sell, make available for sale, or harbour any prohibited animal saving and excepting where permitted by Zoning Bylaw 1999-52.
- b) Notwithstanding the above-mentioned, this by-law shall not apply to:
  - i. the pound, or a shelter lawfully operated by the Ontario Society for the Prevention of Cruelty to Animals;
  - ii. an Animal Hospital or Clinic which is lawfully operated and supervised by a Veterinarian licensed to practice in the province of Ontario:
  - iii. premises registered as research facilities pursuant to the *Animals for Research Act*, R.S.O. 1990, c.A.22.;
  - iv. any person while rendering emergency treatment to an injured or abandoned animal while such animal is unable to fend for itself and provided that there is no danger to any person or other animal;
  - v. the premises of the Town of Amherstburg By-law and Licensing Department, providing the animals are kept in secure, humane, and escape-proof cage, tank or enclosure;
  - vi. any Wildlife Rehabilitation Centre Licensed by the Ontario Ministry of Natural Resources under the Fish & Game Act with a Wildlife Custodian License along with a Salvage Permit issued by the Canadian Wildlife Service under the Migratory Bird Act.

## 3. APPLICATIONS FOR TEMPORARY EXEMPTION:

- a) Applications for exemption under this section may be received by Council.
- b) Each application will be received and reviewed on an individual basis. Council may consult with a panel of experts and either refuse the application or grant a conditional exemption.

## 4. **IMPOUNDING**:

- a) A provincial offences officer may take into his possession any prohibited animal at large or seized under the authority of a search warrant or surrendered to him by the owner.
- b) The pound keeper shall keep a prohibited animal pending the outcome of a court case and appeal period.
- c) Animals surrendered to the pound keeper become the property of the Town and may be kept or adopted out to a lawful recipient.
- d) The pound keeper, or his agent, is authorized to collect the pound fee from the owner levied under this by-law and to maintain a pound as directed by Council.

#### 5. SCHEDULE(S):

Schedule "A" attached hereto forms part of this by-law.

## 6. ENFORCEMENT:

Provincial Offences Officers shall have the duty of enforcing the provisions of this by-law.

## 7. PENALTIES:

Every person who contravenes any provisions of this by-law is guilty of an offence and on conviction is liable to a fine as provided for in the *Provincial Offences Act*, R.S.O. 1990, c.P.33.

## 8. SHORT TITLE:

This by-law shall be referred to as the Exotic Animal By-law.

## 9. REPEAL:

The Town of Amherstburg By-law 2172, being a by-law prohibiting the keeping of animals in defined areas, passed December 10, 1990, be and the same is hereby repealed.

This by-law shall come into force and take effect on the date of final passage thereof.


