

THE CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2005 - 49

Being a by-law for fixing rates for
the supply of water

WHEREAS Section 391 of the *Ontario Municipal Act, 2001*, authorizes a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

AND WHEREAS pursuant to the provisions of Ontario Regulation 244/02 made under the *Ontario Municipal Act, 2001* the Council has provided notice of and held a public meeting at which any person who attended had opportunity to make representation with respect to the setting of the water rates;

AND WHEREAS the Council deems it appropriate and beneficial to set such water rates, and amend those rates from time to time;

NOW THEREFORE the Council of the Corporation of the Town of Amherstburg enacts as follows:

1. The rates for customers supplied potable water by the Town of Amherstburg for the period July 1st, 2005 up to and including June 30th, 2006 shall be at the usage rate and base monthly charge rate as set out in Schedule "A" attached and forming part of this by-law.
2. The rates for customers supplied potable water by the Town of Amherstburg for the period July 1st, 2006 up to and including June 30th, 2007 shall be at the usage rate and base monthly charge rate as set out in Schedule "B" attached and forming part of this by-law.
3. The rates as set out in Schedule "B" attached shall continue in affect after June 30th, 2007 until rescinded or amended.
4. The billing periods and due dates shall be as determined by the Town of Amherstburg in consultation with their billing agent.
5. By-law No. 1998-53 is hereby repealed.

Read a first, second and third time and finally passed this 24th day of May, 2005.

SCHEDULE "A"

BY-LAW NO. 2005 - 49

USAGE RATE

A constant rate charge based on metered water use at \$0.56 per cubic metre.

WATER SERVICE CHARGE

A base monthly charge for each meter depending on water meter size in accordance with the following table:

Meter Size	Monthly Base Charge
5/8 inches	\$12.00
3/4 inches	\$12.00
1 inch	\$16.00
1 1/4 and 1 1/2 inches	\$20.00
2 inches	\$30.00
3 inches	\$40.00
4 inches	\$75.00
6 inches	\$200.00
8 and 10 inches	\$300.00

SCHEDULE "B"

BY-LAW NO. 2005 - 49

USAGE RATE

A constant rate charge based on metered water use at \$0.65 per cubic metre.

WATER SERVICE CHARGE

A base monthly charge for each meter depending on water meter size in accordance with the following table:

Meter Size	Monthly Base Charge
5/8 inches	\$12.25
3/4 inches	\$12.25
1 inch	\$16.30
1 1/4 and 1 1/2 inches	\$20.40
2 inches	\$30.60
3 inches	\$40.80
4 inches	\$76.50
6 inches	\$204.00
8 and 10 inches	\$306.00
