WHEREAS the Council of the Town of Amherstburg has considered the request and has authorized the staff to complete the notification process to change the name of Oram Drive to Crystal Bay Drive; and


WHEREAS staff has given public notice in the following manner:

**NOW THEREFORE THE COUNCIL OF THE CORPORATION
OF THE TOWN OF AMHERSTBURG ENACTS AS FOLLOWS:**

1. That the name of the portion of the highway set forth in column 1 of Schedule “A” annexed hereto and forming part of this bylaw be and the same is hereby changed to the name set forth opposite the same in column 2 of the said Schedule “A” to the extent provided in column 3 of the said Schedule “A”.
2. That this bylaw shall come into force on the date following final passing thereof upon which the same is registered in the Land Registry Office for the Registry Division of Essex (12).

Read a first, second and third time and finally passed this 14th day of November, 2005.
