BY-LAW 2006-93

Being a By-law to amend By-law 2006-76 being a by-law to authorize the sale of a small parcel of land to Mikhail Holdings

WHEREAS By-law 2006-76 was passed on October 10, 2006 and it was discovered that the Corporate names of the transferee should have been shown rather than the name under which the transferee carries on business.

WHEREAS it is the desire of the Town of Amherstburg to make the necessary amendments to properly and legally identify the transferee.


That By-law 2006-76 be amended as follows:

Heading "Being a by-law to authorize the sale of a small parcel of land to Mikhail Holdings" be changed to Being a bylaw to authorize the sale of a small parcel of land to 1318840 Ontario Limited.

- 2nd Paragraph "Whereas Council of the Town of Amherstburg at the regular meeting held on September 11, 2006 has declared the said property as surplus and that the property be sold to Mikhail Holdings, and be changed to Whereas Council of the Town of Amherstburg at the regular meeting held on September 11, 2006 has declared the said property as surplus and that the property be sold to 1318840 Ontario Limited, and.
 - That the property shown in Schedule A attached and forming part of this 1. By-law as Part 3 on Plan 12R22777 (15.24M x 3.05M) be sold to Mikhail Holdings for \$2,366.00 plus legal and survey costs be changed to That the property described as Part 3 on Plan 12R22777 (15.24M x 3.05M) be sold to 1318840 Ontario Limited for \$2,366.00 plus legal and survey costs.

2. That this by-law shall come into force and take effect on the date of the final passing thereof.




