

THE CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2010-41

**Being a by-law for fixing rates for the supply of water and
for fixing rates for the collection and treatment of wastewater**


WHEREAS Section 391 of the *Ontario Municipal Act, 2001*, authorizes a municipality to pass by-laws imposing fees or charges on any class of persons for services or activities provided or done by or on behalf of it;

AND WHEREAS the Council deems it appropriate and beneficial to set such water and wastewater rates, and to amend those rates from time to time;

NOW THEREFORE the Council of the Corporation of the Town of Amherstburg enacts as follows:

1. The rates for customers supplied potable water by the Town of Amherstburg for the period June 1st, 2010 up to and including December 31st, 2010 shall be at the usage rate and base monthly charge rate as set out in Schedule "A" attached and forming part of this by-law.
2. The rates for customers supplied collection and treatment of wastewater by the Town of Amherstburg for the period June 1st, 2010 up to and including December 31st, 2010 shall be at the usage rate and base monthly charge rate as set out in Schedule "B" attached and forming part of this by-law.
3. The rates as set out in Schedule "A" and Schedule "B" attached shall continue in affect after December 31st, 2010 until rescinded or amended.
4. The billing periods and due dates shall be as determined by the Town in consultation with their billing agent.
5. That Town of Amherstburg By-law No. 2007- 99 is herby repealed.

Read a first, second and third time and finally passed this 6th day of April, 2010.

SCHEDULE "A"

BY-LAW NO. 2010 - 41

USAGE RATE

A constant rate charge based on metered water use at \$0.79 per cubic metre.

WATER SERVICE CHARGE

A base monthly charge for each meter depending on water meter size in accordance with the following table:

Meter Size	Monthly Base Charge
5/8 inches	\$15.00
3/4 inches	\$15.00
1 inch	\$19.96
1 1/4 and 1 1/2 inches	\$24.97
2 inches	\$37.45
3 inches	\$49.06
4 inches	\$93.64
6 inches	298.57
8 and 10 inches	\$374.54

SCHEDULE "B"

BY-LAW NO. 2010 - 41

USAGE RATE

A constant rate charge based on metered water use at \$1.61 per cubic metre.

WASTEWATER SERVICE CHARGE

A base monthly charge for each meter depending on water meter size in accordance with the following table:

Meter Size	Monthly Base Charge
$\frac{5}{8}$ inches	\$ 23.87
$\frac{3}{4}$ inches	\$ 23.87
1 inch	\$ 31.82
1 $\frac{1}{4}$ and 1 $\frac{1}{2}$ inches	\$ 39.78
2 inches	\$ 59.67
3 inches	\$ 82.88
4 inches	\$ 149.18
6 inches	\$ 397.80
8 and 10 inches	\$ 596.70
