- 1. That the lands described as Plan 12M-324, Block 13 and Reference Plan 12R-20021, Part 6 with an area of 1396 square meters shown on "Schedule A" attached hereto, in the Town of Amherstburg, County of Essex, Province of Ontario is hereby established as a public roadway.
- 2. The provisions of this by-law shall come into force and take effect on the final reading thereof.


