#### THE CORPORATION OF THE TOWN OF AMHERSTBURG

#### **BY-LAW NO. 2011-50**

### By-law to permit the Town to impose fees or charges

WHEREAS the Municipal Act, 2001, S.O. 2001, c. 25, as amended, provides that a municipality may pass by-laws imposing fees or charges on any class or persons;

**AND WHEREAS** the Building Code Act, 1992, S.O. 1992, c. 23, as amended provides that a municipality may pass by-laws imposing fees and charges;

**AND WHEREAS** the Planning Act, R.S.O. 1990, c. P.13, as amended, provides that a municipality may pass by-laws imposing tariffs, fees and charges.

**AND WHEREAS** on April 11, 2011, Council for the Town of Amherstburg at a public meeting adopted Administrative report dated April 8, 2011, in which certain recommendations were made relating to the 2011 User Fees;

**NOW THEREFORE** the Council of the Corporation of the Town of Amherstburg enacts as follows:

- 1. THAT the rates and service charges, as outlined in Schedule A attached hereto and forming part of this By-law, be implemented and take effect on April 18, 2011, unless otherwise noted in Schedule A.
- 2. THAT such services and activities will not be provided until payment of the appropriate fee or charge has been received.
- THAT payment of any fee or charge in this By-law shall be in Canadian currency.
- 4. THAT Schedule A of By-law 2005-106 is hereby repealed.
- 6. THAT By-laws 2002-79, 2002-80, 2002-86 are hereby repealed.

THIS by-law shall come into full force and effect upon the final passing thereof.
