By-law to amend By-law 2011-69 being By-law to Regulate Traffic in the Town of Amherstburg

WHEARES the Council of the Corporation of the Town of Amherstburg hereby deems it expedient to amend By-law 2011-69, being a By-law to Regulate Traffic in the Town of Amherstburg;
