BY-LAW NO. 2012-67

By-law to amend By-law 2011-69
being By-law to Regulate Traffic in the Town of Amherstburg

WHEARES the Council of the Corporation of the Town of Amherstburg hereby deems it expedient to amend By-law 2011-69, being a By-law to Regulate Traffic in the Town of Amherstburg;

NOW THEREFORE the Council of the Corporation of the Town of Amherstburg hereby enacts as follows:

- 1. By-law 2011-69 is hereby amended as follows:
(a) By adding to Schedule "B" thereto the following items:

Table with 5 columns: Column 1 HIGHWAY, Column 2 SIDE, Column 3 FROM, Column 4 TO, Column 5 PROHIBITED TIMES. Title: SCHEDULE "B" NO PARKING. Rows include Fort St., Kingsbridge Rd., McLellan Ave., and Murray St. with various side and time restrictions.

- 2. By-law 2011-69 is hereby amended as follows:
(a) by adding to Schedule "J" thereto the following items:

Table with 2 columns: Column 1 INTERSECTION, Column 2 FACING TRAFFIC. Title: SCHEDULE "J" STOP SIGNS. Rows include Dalhousie & North St. and Girard St. & Brunner Ave.

- 3. By-law 2011-69 is hereby amended as follows:
(a) by adding to Schedule "L" thereto the following items:

Table with 3 columns: Column 1 HIGHWAY, Column 2 BETWEEN, Column 3 SPEED. Title: SCHEDULE "L" INCREASED AND DECREASED SPEED LIMITS. Row includes Golfview Dr. with speed limit of 50 km/h.

4. By-law 2011-69 is hereby amended as follows:
 (a) by deleting the following from Schedule "B"

5. By-law 2011-69 is hereby amended as follows:
 (a) by adding the following to Schedule "B"

Gore St.	North	Dalhousie St.	Sandwich St.	Anytime
Gore St.	South	59m east of Dalhousie St.	Dalhousie St.	Anytime

6. That By-law 2008-18 be repealed.
7. That this By-law shall come into full force and effect when the appropriate signs have been erected and are on display.
8. That all other provisions of By-law 2011-69 remain in full force and effect.
