#### **BY-LAW NO. 2012-83**

## A By-law to amend By-law 2010-95

**WHEREAS** By-law 2010-95 being a by-law to remove certain lands from Part Lot Control was passed by the Council of the Corporation of the Town of Amherstburg on the 27<sup>th</sup> day of September, 2010;

AND WHEREAS the Manager, Planning Services for the County of Essex approved By-law 2010-95 pursuant to Section 50(7) of the Planning Act on October 13, 2010;

AND WHEREAS By-law 2010-95 provided an expiration date of September 27, 2012;

AND WHEREAS the Owner has requested an extension of the expiration date;

**AND WHEREAS** Section 50 (7.4) of the Planning Act provides that the Council of a local municipality may, at any time before the expiration of a by-law under subsection (7), amend the by-law to extend the time period specified for the expiration of the by-law and an approval under subsection (7.1) is not required.

**AND WHEREAS** Section 50 (7.5) of the Planning Act provides that the Council of a local municipality may repeal or amend a by-law passed under subsection (7) to delete part of the land described in it and an approval under subsection (7.1) is not required.

# NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

- 1. That By-law 2010-95 is hereby amended to provide for an expiration date of September 10, 2014.
- 2. That Subsection 1 of By-law 2010-95 is hereby amended to read as follows;

Subsection 5 of Section 50 of the Planning Act, RSO 1990, Chapter P13 does not apply to the following;

All and singular those certain parcels or tracts of land and premises situate, lying and being in the Town of Amherstburg, the County of Essex, and Province of Ontario and being composed of Parts of Block 71, Plan 12M-517, designated as Parts 4, 5 and 6, Plan 12R-24770 and Part of Block 71, Plan 12M-517, designated as Part 39, Plan 12R-22160, save and except Parts 1 through 6, Plan 12R-23744 and Part of Block 70, Plan 12M-517, lying North of Parts 5 and 6, Plan 12R-24079 and Part of Block 70, Plan 12M-517, lying between Block 68, Plan 12M-517 and Plan 12R-24464, all known locally as a portion of the Golfview Subdivision.

3. That all other provisions of By-law 2010-95 remain in full force and effect.
