

**THE CORPORATION OF THE TOWN OF AMHERSTBURG
BY-LAW NO. 2015-95**

**By-law to dedicate certain lands in the
Town of Amherstburg as a Public Highway
(Old Colony Trail)**

WHEREAS the Municipal Act, R.S.O. 2001, c.25 Sections 24-68 authorizes the Council of every municipality to pass a by-law for establishing, laying out, acquiring, assuming, or naming a highway;

AND WHEREAS the Council of the Township of Anderdon entered into a subdivision agreement on August 22, 1997 with 957501 Ontario Limited;

AND WHEREAS land has been transferred to the Town for the continuation of Old Colony Trail described as follows:


Plan 12M-394, Block 168

Area 6.8 sq m


NOW THEREFORE the Council of the Corporation of the Town of Amherstburg enacts as follows:

1. THAT the lands described as 12M-394, Block 168, with an area of 6.8 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby established as a public roadway, to be named Old Colony Trail.
2. THAT this By-law shall come into force and take effect immediately upon the final passing thereof at which time all by-laws that are inconsistent with the provisions of this by-law and the same are hereby amended insofar as it is necessary to give effect to the provisions of this by-law.

Read a first, second and third time and finally passed this 14th day of September, 2015.
