## By-law to dedicate certain lands in the Town of Amherstburg as a Public Highway (Gibb Street)

**AND WHEREAS** the land has been transferred in title to the Town and it is now appropriate to dedicate Part 7, 12R-26175 as a continuation of Gibb Street as follows:

## <u>12R- 26175, Part 7</u> Area 782.13 sq m

**NOW THEREFORE** the Council of the Corporation of the Town of Amherstburg enacts as follows:


