## By-law to dedicate certain lands in the Town of Amherstburg as a Public Highway (Gibb Street)

**WHEREAS** the Municipal Act, R.S.O. 2001, c.25 Sections 24-68 authorizes the Council of every municipality to pass a by-law for establishing, laying out, acquiring, assuming, or naming a highway;

**AND WHEREAS** the land has been transferred in title to the Town and it is now appropriate to dedicate Block 49, 12M245 as a continuation of Gibb Street as follows:

#### <u>12M245, Block 49</u> Area 6 sq m

**AND WHEREAS** the land has been transferred in title to the Town and it is now appropriate to dedicate Block 20, M159 as a continuation of Gibb Street as follows:

## M159, Block 20 Area 6 sq m

**NOW THEREFORE** the Council of the Corporation of the Town of Amherstburg enacts as follows:

- 1. THAT the lands described as Block 49, 12M245 with an area of 6 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby dedicated as a public highway, and forms part of Gibb Street.
- 2. THAT the lands described as Block 20, M159 with an area of 6 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby dedicated as a public highway, and forms part of Gibb Street.
- 3. THAT this By-law shall come into force and take effect immediately upon the final passing thereof at which time all by-laws that are inconsistent with the provisions of this by-law and the same are hereby amended insofar as it is necessary to give effect to the provisions of this by-law.

Read a first, second and third time and finally passed this 11<sup>th</sup> day of September, 2017.
