# By-law to dedicate certain lands in the Town of Amherstburg as a Public Highway (Fryer Street)

**WHEREAS** the Municipal Act, R.S.O. 2001, c.25 Sections 24-68 authorizes the Council of every municipality to pass a by-law for establishing, laying out, acquiring, assuming, or naming a highway;

**AND WHEREAS** the sale of Part 1, 12R27349 has been transferred in title to the Greater Essex County District School Board and it is now appropriate to dedicate Parts 2, 6 and 7, 12R27349 for the widening of Fryer Street as follows:

12R27349, Parts 2, 6 and 7

Area 1678.27 sq m

**NOW THEREFORE** the Council of the Corporation of the Town of Amherstburg enacts as follows:

- 1. THAT the lands described as Parts 2, 6 and 7, 12R27349, Part of PIN 70558-0201 and Part of PIN 70558-0149 and Part of PIN 70558-0292, with an area of 1678.27 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby dedicated as a public highway, and forms part of Fryer Street.
- 2. THAT this By-law shall come into force and take effect immediately upon the final passing thereof at which time all by-laws that are inconsistent with the provisions of this by-law and the same are hereby amended insofar as it is necessary to give effect to the provisions of this by-law.
