
NOW THEREFORE the Council of the Corporation of the Town of Amherstburg hereby enacts as follows:

CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2004-89

Being a By-law to regulate the use of the King's Navy Yard Park

WHEREAS the Municipal Act 2001 S.O. c25 Section 11 (5) authorizes a municipality to pass by-laws respecting matters relating to culture, parks, recreation and heritage; and

WHEREAS the Council of the Town of Amherstburg passed By-law 2002-72 being a by-law to regulate the use of parks; and

WHEREAS the King's Navy Yard Park was created in two phases from input received at public meetings; and

WHEREAS Grant money was given to the Town by federal and provincial agencies under the conditions that local committees be formed to define the nature and uses of the park; and

WHEREAS the consensus was that the park would be a well designed, landscaped and passive waterfront park; and

WHEREAS the Council of the Town of Amherstburg considers it appropriate and necessary to pass a by-law to further regulate the use of the King's Navy Yard Park due to the Town's original and continuing intention to develop and maintain the area as a passive, well designed, delicately landscaped, waterfront park.

NOW THEREFORE THE COUNCIL OF THE TOWN

OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

The following rules and regulations are specific to the King's Navy Yard Park and are in addition to regulations specified in By-law 2002-72.

1. In order to protect the turf, sprinkler system and gardens, no vehicular traffic of any kind will be allowed except for public works and handicap vehicles. Bicycling, rollerblading, skateboarding, in-line skating or the like will not be allowed for the same reasons and for the safety of pedestrians.
2. The park shall not be used for commercial purposes.
3. Public, private and non-profit functions will be allowed by permit. This will protect the grounds, the gardens, sprinkler system and facilities and at the same time simplify the scheduling of such events. Council retains final discretion in the awarding of permits.
4. Additionally:
 - a) All dogs will be leashed and owners are responsible for cleanup.
 - b) Fishing will be allowed at the designated fishing areas. ~~in the south end of the park.~~ (amended B/L 2018-98, Oct 23/18)
 - c) There will be a curfew from 12:00 a.m. to 6:00 a.m. for all unauthorized persons.

Every person shall obey any temporary or permanent exclusion order or direction of any police officer, caretaker, or other person authorized by Council.

BY-LAW 2004-89

Any person violating any of the provisions of this by-law shall be liable upon conviction thereof to a penalty not exceeding (\$2,000.00) two thousand dollars, exclusive of costs and the same shall be recoverable under the provisions of the Provincial Offences Act.

This by-law shall come into force and take effect on the final passage thereof.
