CORPORATION OF THE TOWN OF AMHERSTBURG BY-LAW NO. 2020-064

By-law to amend Zoning By-law No. 1999-52 W/S Victoria Street South, Amherstburg

WHEREAS By-law 1999-52, as amended, is a land use control by-law regulating the use of lands and the character, location and use of buildings and structures within the Town of Amherstburg;

AND WHEREAS the Council of the Town of Amherstburg deems it appropriate and in the best interest of proper planning to amend By-law 1999-52, as herein provided;

AND WHEREAS this By-law conforms to the Official Plan for the Town of Amherstburg;

NOW THEREFORE the Council of the Corporation of the Town of Amherstburg enacts as follows:

- 1. Schedule "A", Map 46 of By-law 1999-52, as amended, is hereby amended by changing the zone symbol on those lands shown as "Zone Change from R1 to R1-15" on Schedule "A" attached hereto and forming part of this By-law from "Residential First Density (R1) Zone" to "Special Provision Residential First Density (R1-15) Zone".
- 2. "Section 5(4)(n) R1-15 (W/S Victoria Street South)

Notwithstanding any other provisions of this By-law to the contrary, within any area zoned R1-15 on Schedule 'A' hereto, the zone requirements of Section 5 of this By-law shall apply with the exception of the following:

- (i) R1-15 Permitted Uses
 - 1. Semi-detached dwelling;
 - 2. Any use permitted in the R1 Zone.
- (ii) R1-15 Zone Requirements
 - 1. Lot Area (minimum)

i.	Semi-detached	dwelling	8	50 m^2
	Semi-detached	dwelling unit	: 4	20 m ²

2. Lot Frontage (minimum)

i.	Semi-detached dwelling	26 m
	Semi-detached dwelling unit	12 m

3. Lot Coverage for Semi-detached dwelling (maximum)

40%

4. Dwelling Unit Area (minimum)

i. Semi-detached unit 65 m²"


