There were no disclosures of pecuniary interest.

APPOINTMENT OF CHAIR:

Moved by G. Theriault, seconded by T. DiBartolomeo that Mayor Hurst be appointed as Chair of the Drainage Court of Revision for the current term of Council.

1. **CULVERT OVER 2ND CONCESSION DRAIN**

There were no letters received from ratepayers and no ratepayers present.

Tony DiCiocco explained that the owner who requested the bridge is paying 100% of the cost and that a waiver has been signed by the owner relinquishing his rights of appeal. Also Mr. DiCiocco further explained that when the report was prepared it was not realized that the property was agricultural, and the project should be eligible for the Provincial Farm Drainage Grant.

Moved by R. Pillon, seconded by G. Theriault that the report for the Culvert over the 2nd Concession Drain dated January 26, 1998, be adopted, subject to administration making application for a grant in the amount of 33-1/3%, which is currently available for private lands used for agricultural purposes from the Ontario Ministry of Agriculture and Food and Rural Affairs in accordance with Sections 85, 86, 87 and 88 of the Drainage Act.

2. **BRIDGES OVER THE LAFFERTY-BEZAIRE DRAIN**

There were no letters received from ratepayers and no ratepayers present.

Tony DiCiocco explained that the owner who requested the bridges is paying 100% of the cost and has signed a waiver relinquishing his rights of appeal.

Moved by R. Anderson, seconded by G. Theriault that the report for the Bridges over Lafferty-Bezaire Drain dated December 19, 1997, be adopted.

3. REPAIR AND IMPROVEMENT OF IMESON-MELOCHE DRAIN

There were no letters received from ratepayers and no ratepayers present.

Mr. Zarlenga reviewed and explained the addendum report dated March 17, 1998. The main changes covered in the addendum report were the elimination of the construction of the bridge on the Mialkowski lands and the reduction in hectares assessed on the Mialkowski lands from 4.047 hectares to 2.145 hectares. The total estimate of cost was changed from \$28,600.00 to \$25,400.00.

Moved by T. Tiefenbach, seconded by T. DiBartolomeo that the report for the Repair and Improvement of Imeson-Meloche Drain dated December 23, 1997, along with the Addendum Drainage Report dated March 17, 1998, be adopted.

4. REPAIR AND IMPROVEMENT OF THE BEAUDOIN DRAIN AND BRANCH

There were no letters received from ratepayers and no ratepayers present.

Mr. Zarlenga explained that the addendum report dated March 17, 1998 was prepared because of a bridge not needed on the Harvey Bezaire property.

Moved by G. Theriault, seconded by T. Tiefenbach that the report for the Repair and Improvement of the Beaudoin Drain and Branch December 23, 1997, along with the Addendum Drainage Report dated March 17, 1998, be adopted.
