BEAUDOIN DRAIN & BRANCH

Mr. Lou Zarlenga reviewed the Report for the Beaudoin Drain & Branch dated December 23, 1997.

- Estimated Cost - \$30,300.00
- Agricultural grant for eligible lands

Mr. Harvey Bezaire, 3795 3rd Concession Rd., had previously contacted the Drainage Superintendent regarding his culvert.

Mr. Leo Bastien, 3828 3rd Concession Rd., spoke about the Ena Beneteau property. He requested a rock chute to control erosion.
