Mayor Hurst introduced Jean Monteith from Monteith and Associates and asked that she review the report entitled Town of Amherstburg Development Charges Study (Residential). Mrs. Monteith explained the report to those in attendance. She noted the various changes from the old Act to the new Act, and made specific note that costs now reflected a 10 year average as opposed to the highest level over the previous ten years. She also indicated that some services must be discounted in accordance with the Act, and some costs are further discounted because the services are not used by commercial or industrial development.

When the servicing charges of various areas were reviewed, it was evident that there was little difference in cost. Therefore, it was decided that a uniform fee across the municipality would be beneficial for everyone. The current charges in existing development agreements will remain in force. The proposed by-law establishes a procedure to credit developers if they incur costs for items listed as relating to the development charge.
