PETITIONS & DEPUTATIONS

Ronald Sutherland, representing the Boaters Association, addressed Council on various questions that were the result of an April 23rd Boaters meeting.

- 1. Requested permission for any boaters that decided to leave Marina due to lack of a decision on dredging to get their well back next season provided they leave their \$100.00 deposit.
- 2. Boaters allowed to defer payment deadline to end of May.
- 3. At the April 23rd meeting the 28 Boaters present preferred spring dredging with the request to stop working from Friday noon to and including Sunday.
- 4. Requesting a list of all boaters who have deposited \$100.00.
- 5. Requested that quiet time be at 11:00 p.m. rather than 10:00 p.m.

Dan Krutsch of BTS Consulting spoke on the proposed dredging project. He cited some benefits of doing the dredging in the fall. Generally the more conditions and restraints that are placed on the contract - the higher the price although he could not predict what the contractors may actually bid on spring dredging versus fall dredging. There could be restricted access to the River Canard channel because of dredging machinery and floating pipes. Five contractors have pre-qualified for the work and approval would likely be available to dredge after June 20.

A lengthy discussion took place on the pros and cons of spring versus fall dredging.

Moved by M. Bezaire, seconded by A. Leardi that we concur with the boaters request that if they leave the Marina and keep a \$100.00 deposit that they receive their well back the following season.
