An application has been submitted to the Ministry of Municipal Affairs and Housing for approval of a draft plan of condominium under Section 51(20) of the Planning Act for property located on Bois Blanc Island.

- (ii) Letter dated August 26, 2002 from Sam Vucinic on behalf of John and Dianne Pandolfo.

With respect to the Vucinic letter, it was clarified that this application for condominium approval is for the existing building currently being completed, not for additional condominiums.

Council passed a development agreement on January 28, 2002 under By-law 2002-08.

The Ministry of Municipal Affairs and Housing has requested the Town to hold a public meeting and forward a record of the public meeting and comments received to their Ministry.

Ron Renaud noted that, in his opinion, the advertisement was not clear in referencing the existing structure.
