DELEGATIONS

Delegation # 1

Mr. Anthony Leardi, on behalf of the Ranta Marina Boaters' Association, deferred his delegation to address Council regarding the Ranta Marina.

PRESENTATIONS

Presentation #1

The Parks Committee made a presentation to Council regarding a proposed Kayak Launch and a proposed Walking and Biking trail.

Mr. Dante Pagliaroli, Chairman of the Parks Advisory Committee addressed Council regarding potential development of a Kayak Launch and Walking and Biking Trail. Mr. Pagliaroli stated the mandate of the Parks Committee is to look at inexpensive ways to make our community attractive. Mr. Pagliaroli proposed a biking and walking trail to begin at Larry Bauer Park shown on the attached map. Mr. Pagliaroli stated that this route was selected primarily due to the availability of parking and the future availability of washroom facility at Larry Bauer Park.

Mr. Pagliaroli discussed a Kayak Launch at the foot of Texas Road. Mr. Pagliaroli indicated that there are approximately 250 kayakers who are members of various clubs in Essex County and because of our location; Amherstburg is a much desired destination. Mr. Pagliaroli indicated that the access point shown on mapping is Duffy's tavern which

is no longer an active launch site. The proposed paddlers launch can be accommodated at the foot of Texas Road on Town owned property with parking being permitted by the adjacent land owner. Mr. Pagliaroli stated that once the kayakers finish paddling, it is likely they will frequent Town restaurants and businesses. Mr. Pagliaroli indicated the fact that there is some urgency to the request as the mapping for "Your Guide to Essex County" will be going to print early in the New Year. This publication is published on a 10 year cycle and the Parks Committee wished to take full advantage of this opportunity. The financial impact of this project is estimated at \$4,500.00 and Mr. Pagliaroli requested a decision prior to January 2009.

Discussion:

Councillor Pillon expressed concerns with respect to the grade of the site. The delegation indicated that the site would be graded. Tony DeThomasis, Supervisor of Parks and Roads indicated that the adjacent land owner is willing to sign an agreement to use his property for parking vehicles, unload and reload kayaks and the owner indicated his willingness to donate stone for this purpose.

Councillor Fryer asked what type of road would be required to access the launch. The delegation responded that the Kayakers are asking for a gravel surface and the estimate of \$4500 inclusive of stone and grading would be sufficient.

Deputy Mayor Bailey suggested that consideration be given to River Canard Park as a possible launch site as this site would provide parking.
