I am requesting that you pass two motions this evening. First and foremost that you reinstate the motion that council review and question the payment of accounts on a monthly basis. This is perhaps one of the most important functions of council. It is your right, indeed it is your obligation to do so. When you gave up this very important function, it appears you lost control of spending our tax dollars.

Secondly, I am requesting that you pass a motion for council to make public the final cost of the King's Navy Yard Parkette, including any and all costs associated with labour and supplies, which may have been inadvertantly put in the public works budget, instead of the actual cost of the parkette. Included in this report, I am requesting the final cost that the developer actually paid for damages incurred during construction and the date this account was paid in full. I am asking for a recorded vote on both motions.

Now, to be honest with you, I already know the cost of this parkette due to a Freedom of Information request that was filed a year ago and delayed for six months. We gave you an extra six months to release this report to the public. You neglected to do so, perhaps out of embarrassment or fear, knowing that the general public would be angry, believing that we were initially mislead by the mayor, who assured us the parkette would be restored at no cost to the taxpayers. In fact, both our local newspapers wrote editorials supporting this claim.

Further to that, I believe that council fully understood that our taxpayers would be outraged, when they discovered the final cost of this very small area of the parkette, that is equal to a medium or large size lot, is allegedly over half the asking price of the Ranta Marina which consists of 13.9 acres, 104 boatwells, and a public boat launch on prime real estate property on the Detroit River.

Councillors, how could you justify such outrageous spending on enhancements? Is this the real reason why you are selling the Ranta Marina at such a ridiculously low price, in order to cover the cost of the parkette that was not supposed to cost the taxpayers any money?

Secret meetings, voting to sell public property without supplying

councillors terms and conditions of agreements, destroying our environment, breaking town by-laws again and again, not tendering large amounts of money, out of control hiring and spending, rushing through projects without public input. Enough is enough. This behavior is totally unacceptable. Members of council, I am serving you notice. From this day forward, we are taking back our town.

The first motion is to make public all pertinent information relating to the division of the Walter Ranta Memorial Park and Marina. There have been discussions as to when the park and marina were divided. According to some previous council members, the last council voted to separate the park and marina. If this separation did occur, I am requesting a copy of all public or in camera meetings whereby a decision was made to divide this property, the survey showing the division, a copy of the application for severance and any rezoning changes.

The second motion is in regard to the declaration of Walter Ranta Marina as surplus. I am requesting that you present to the public the minutes of any public meetings declaring the marina surplus, as well as the dates and means by which these meetings were advertised. Included in this motion, I am also requesting a copy of a surplus study if one was undertaken, the name of the company that conducted the surplus study and a full disclosure of tax dollars spent.

In order for council to be transparent to the citizens of Amherstburg, all information needs to be disclosed in a Public Meeting that has been advertised in the local newspapers. I am also requesting a recorded vote on these motions and all of the information sent to my address, which is provided. I believe it is wrong to sell our only public marina especially in the current economic climate where the marina's true value cannot be received. It is imperative that the citizens of Amherstburg discover the truth behind this sale.

Could it be our well kept historic museum, beautiful parks, the Gordon House, pretty signs and walking trail, the track, tennis courts, baseball and soccer fields, the new safe playground, the Lion's pool, the splash park, our flower pots, new parking lots and how about the kayak launch and ice arena? Are any of these CORE SERVICES? Do any of these make money? ARE ANY OF THESE FOR SALE? Are dockominiums a core service?

Mr. Fryer and Mr. Pillon seem to feel that Ranta Marina is a core service and therefore it is wrong to sell it. So do I.

Since this seems to be a "done deal", as a voter, I have a few questions:

- how is the town going to benefit from the sale of the marina when you are only recouping half of the so called debt?

- how was it decided that Ranta Marina was surplus land?

- who appraised Ranta Marina and why was this appraisal accepted?

- if the assessed value for the marina is \$1,300,000, why was it sold for a little over half of a million dollars?

- is the developer going to be taxed on the assessed value or on what he payed for the property?

-if the condo developer needs more land, are you going to give the adjoining park also?

-in the future, will the town be paying for a new public boat launch elsewhere?

-how much will it cost us to provide services for the new condos. Will it be similar to the Navy Yard Park issue? Will we pay to rearrange the park for him, or remove trees to improve their view of the river?

- if Ranta Marina was developed with almost \$3,000,000 in Federal and Provincial grants, why are you selling it for the <u>bargain basement price of</u> <u>\$584,000?</u>

- if the town's portion of the new sports complex is \$8,000,000, where is this money coming from?

- how will you pay to operate and maintain this new sports complex?

- and when this new complex runs a deficit (like the current arena does), are you going to sell it to?

In closing, if you can't afford to maintain an established marina, how can you afford 8 times that amount to build this new complex and the further expenses to operate and maintain it?

Ranta Marina is not just for boaters today, but for your children and future generations to enjoy Amherstburg's greatest asset.

After basically giving away our marina, <u>please</u> do not raise our taxes to pay for a sports complex. Remember we are trying to have faith in you, our honourable town leaders.
