# **REPORTS OF MUNICIPAL OFFICERS**

## Report #1

A report from Lory Bratt, Planning Coordinator dated October 14, 2009 regarding the Development Charges Study and By-law.

Lory Bratt, Planning Coordinator explained the report before Council. She noted that the fees represent a slight decrease to those fees contained in the current by-law for lands on full municipal services and a slight increase for lands outside the sanitary sewer service area. Jean Monteith, Planning Consultant explained the reasoning for the decrease in the fees.

Councillor R. White asked if the exercise could be done every ten years versus every five years. Jean Monteith noted that the Planning department has finalized an accurate inventory which will assist in the next study. If this inventory is kept up to date, a five year review will not be a major undertaking and could most likely be done in-house.

Councillor R. Pillon sought clarification as to the reduction in fees when there is upgrading that must occur in order for future development.

Deputy Mayor Bailey referred to page 14 of the report regarding commentary on parkland and questioned whether consideration has been given to the Massen lands. Jean Monteith confirmed same.

Deputy Mayor Bailey referred to the chart on page 18 of the attached report and inventory of existing municipal buildings. He referred to arena community centre and library replacement values and asked how those figures have been arrived at. Jean Monteith noted that the replacement value is based on what exists now and on the current insurance value.
