UNFINISHED BUSINESS

- Councillor Pouget requested an update regarding the RFP for legal services.
 The Chief Administrative Officer stated that Administration is in the process of gathering a number of RPF's from peer municipalities. Once an RFP is created for the Town, it will come back to Council for consideration.
- Councillor Meloche requested an update regarding the turning lanes at the intersection of Sandwich and Simcoe Street. The Director of Engineering and Public Works stated that, as per Council direction, a cost proposal will be brought to budget deliberations.

- Councillor Pouget requested an update regarding Mike Phipps, former CAO, and the neglect of his duties. The Chief Administration Officer stated that he will provide Council with the report at the February 23, 2015, Regular Council Meeting.
- 4. Councillor Pouget requested an update regarding correspondence to neighbouring municipalities requesting a formal costing of joint Police Services. The Chief Administrative Officer advised that there were recent discussions at the CAO meeting. Once additional information is gathered from the Amherstburg Police Chief, formal correspondence will be sent to neighbouring municipalities.

NEW BUSINESS

- Councillor Meloche requested an update on snow removal during the recent snow storm. The Director of Engineering and Public Works stated that the last snow storm was a challenge due to the duration of the snowfall. The Director of Engineering and Public Works stated that the removal process fared well and the department received some positive comments and also some concerns that were addressed.
- 2. Councillor Meloche inquired as to when budget deliberation dates will be set. The Chief Administrative Officer advised that Administration plans to table the budget for the February 23, 2015, Regular Council Meeting. Once the budget is tabled, 3 public meetings will occur to include community input in relation to the budget. After public input is gathered, Administration will report back to Council with the public feedback.
- 3. Councillor Meloche inquired on Amherstburg's role in regards to reserving funds for the proposed new hospital. The Chief Administrative Officer advised that the budget for Council's consideration includes enhancement of reserves. He stated that building the reserves to be utilized for unforeseen expenses, such as the proposed hospital, formed a part of the 41 recommendations of the Deloitte Report. He also noted that the Province has not yet approved the hospital project.
- 4. Councillor Meloche inquired on the use of the Town parking lots. The Director of Economic and Community Development stated that he met with the Chamber of Commerce who echoed similar concerns. He stated that the Chamber of Commerce was provided a list of all Town lots and curbside parking for businesses and they are working together to educate business owners and their employees on where to park. He also stated that a report will be coming before Council with recommendations to rectify the parking concerns.

- 5. Councillor Courtney advised Administration of a complaint regarding the tobogganing hill at the Libro Credit Union Center. The Chief Administrative Officer responded that that hill has never been groomed as a tobogganing hill; the community uses it on their own accord which is a liability to the Town. Administration is in the process of installing signage stating that the Town prohibits the use of the hill for tobogganing. Councillor Courtney asked what the difference is between the tobogganing hill at Centennial Park as compared to the hill at the Libro Credit Union Complex. The Municipal Clerk stated that the hill at Centennial Park has been properly groomed for tobogganing and the hill at the Libro Credit Union Complex has not which makes it hazardous. The Clerk also advised Council that there have been at least 2 accidents resulting in broken bones at the Libro Center hill.
- 6. Councillor Pouget asked that the Mayor and Deputy Mayor provide Council with information regarding Toronto garbage when it is discussed at County Council. She stated that the information will be necessary so that Council can bring forward their input on the matter.
- 7. Councillor Lavigne moved, Councillor Pouget seconded:

That Administration provide a report regarding any documentation from the Special Events Committee including the minutes of their meetings pertaining to the Mardi Gras event sponsored by the Amherstburg Chamber of Commerce for 2015. The report should include any documents and approval from the Police and Fire Departments and the Traffic Committee. The report will provide Council with any anticipated costs to the tax payers for this event. The report should be provided at the next Council meeting or convenience.
