CALL TO ORDER

The Mayor called the meeting to order at 6:18 pm.

DISCLOSURE OF PECUNIARY INTEREST & GENERAL NATURE THEREOF

There were no disclosures of pecuniary interest noted.

PRESENTATIONS

3.1 Proposed 2015 Budget

The CAO, the Director of Financial Services/Treasurer and the Manager of Financial Services/Deputy Treasurer presented the Proposed 2015 Budget to Council.

Councillor Fryer requested copies of the presentation and speaking notes for all of Council.

Councillor Meloche requested a more comprehensive wage component of the operating costs. The Director of Financial Services advised that he would provide a summary for Councils review.

Councillor Lavigne inquired whether a risk analysis had been done with respect to the proposed Fire and Public Works movement. The CAO advised that the Fire Chief believes a 10-10 response time can still be maintained. However the budget is first approved in principle and any movement will be investigated further prior to completion.

That Council waive rules of order and allow members of the gallery to speak.

Councillor Fryer inquired as to when the last Fire Master Plan was completed and requested the information be brought to the March 9, 2015 Regular Council Meeting.

Discussion ensued with respect to Supplementary report item - Ontario Community Infrastructure Fund (OCIF) - Texas Road.

The CAO stated that option 2 for \$4.4M was proposed in the capital budget and it will be completed unless Council directs differently.

Councillor Meloche moved, Councillor Lavigne seconded:

That Council take a 5 minute break.

That Council table the proposed 2015 budget until March 31 and add an additional meeting date to the public budget information schedule for the Anderdon area not to be held on a Thursday evening.
