- 3. The Chief Administrative Officer BE AUTHORIZED to issue a Purchase Order in the amount of \$161,085.18 plus HST to Carpell Surfaces, 745 Vandals, Granbt, Quebec J2J 1H8 to BE FUNDED from the Amherstburg Community Foundation donation received for the Miracle Diamond;
- 4. The Chief Administrative Officer BE AUTHORIZED to issue a Purchase Order in the amount of \$15,000 plus HST to Carpell Surfaces, 745 Vandals, Granbt, Quebec J2J 1H8 to be funded from the Tax Stabilization Reserve;
- 5. The Town of Amherstburg AUTHORIZE the Board of Directors of the Miracle League to manage the project; and,
- 6. Administration BE AUTHORIZED to enter into a Licence Agreement with the Amherstburg Miracle League for a term of 5 years.
