3. Councillor Courtney advised Council that drivers are racing to get through the green traffic light on Fryer Street at the intersection of Fryer Street and Simcoe Street. She asked the Police Chief if speeding tickets are given out on the stretch between Pickering Street to Simcoe Street to deter speeding. She also asked if the light can be adjusted so that it remains green longer on Fryer Street (going north/south).

The Police Chief advised Council that Fryer Street can be added to the data collection list which will provide information with respect to how many cars are using that specific area, the speed in which they are travelling, and when the most infractions are occurring.

The Director of Engineering and Public Works stated that she can look into the traffic counts for that intersection and determine if there are any adjustments that can be made.
