UNFINISHED BUSINESS

 Councillor Fryer asked for an update with respect to changing the traffic signals so that traffic going south on Sandwich Street is delayed in order to allow more traffic to flow going north on Sandwich Street to prevent the congestion that is occurring all the way to Pickering Street.

The Director of Engineering and Public Works advised Council that calls have been made to the County; however, there is only one person who provides the service to all surrounding municipalities.

Councillor Pouget advised that she was concerned that resolution regarding the Amherstburg Community Foundation was not brought forward for consideration at this meeting.

The Clerk advised that the resolution from the October 23, 2018, Regular Council Meeting would have to be reconsidered first as per the Procedural By-law.

The Chief Administrative Officer advised Council that the request was made to the Amherstburg Community Foundation; however, the Foundation hasn't had a recent meeting in order for him to get the information being requested by Council.

3. Councillor Pouget advised that she was concerned that resolutions regarding the Dog Kennel By-law and the Fill By-law were not brought forward for consideration at this meeting.

The Manager of Licencing and Enforcement advised Council that she has been in contact with 15 different municipalities, spoken to acoustic engineers for noise assessments, and reviewed a euro study regarding noise assessments. She further advised that she is in the process of compiling the information for a report, as well as a draft by-law, to be tabled before Council along with public consultation

NEW BUSINESS

1. Councillor Fryer expressed his concern with respect to the recent issue with the 911 system where alerts were sent out indicating a brief malfunction.

The Chief of Police advised Council the information he received was that the only the cellular data lines were affected and that it was a province-wide problem and he is unsure as to what caused it.
