5.1 Investing in Canada Infrastructure Program (ICIP) Green Stream - Transfer Payment Agreement

A capital expenditure not to exceed \$2,337,500 including net HST BE APPROVED, including a 2021 over-expenditure not to exceed \$100,000 and a pre-commitment not to exceed \$2,237,500 for future budget years, for reconstruction of sanitary sewers on George and Seymour Street, to be funded from the Investing in Canada Infrastructure Program (ICIP): Green Stream and a transfer from the Wastewater Reserve;
- 2. Administration BE AUTHORIZED to enter into a Transfer Payment Agreement for an Investing in Canada Infrastructure Program (ICIP): Green Stream Project with the Minister of Infrastructure for funding of up to \$1,714,088.75 toward reconstruction of the Sanitary Sewer System on George and Seymour Street at a total project cost not to exceed \$2,337,500 including net HST; and,
- 3. By-law 2021-047 being a by-law to enter into a Transfer Payment Agreement for the Investing in Canada Infrastructure Program (ICIP): Green Stream with Minister of Infrastructure BE TAKEN as having been

NEW BUSINESS

1. Deputy Mayor Meloche asked about the percentage of greenspace on the Park's proposals.

The Chief Administrative Officer advised that Administration is going to bring those calculations forward for future consideration in the public consultation session. He further advised that the survey closes on August 1st, 2021, and the results will be shared at the September 27th, 2021, Regular Council Meeting.

2. Deputy Mayor Meloche asked for an update with respect to the former Duffy's property.

The Chief Administrative Officer advised that he is currently finalizing the Ministry requirements and then will be awaiting the Ministry approvals.

3. Deputy Mayor Meloche advised of a missing section of sidewalk in McGregor.

The Director of Infrastructure Services advised that she will follow up with the resident who has standing water on their property, which in turn, affects the abutting sidewalk; and further, she will ensure that the work the Town is responsible for is completed.

- 4. Councillor McArthur advised of concerns with respect to the speed of construction vehicles on Texas Road going in and out of the Kingsbridge subdivision. Councillor McArthur noted that Windsor Police Staff Sergeant Cheney advised that Police and Administration are aware of the concern and the construction companies are being contacted; and further, there is an increased Police presence in the area.
- 5. Councillor Prue advised of flood complaints in the Kingsbridge Subdivision where residents believe is occurring as a result of development in the area.

The Clerk advised that the matter is currently being investigated by the Infrastructure Services and Building Departments and incoming claims are being handled by the Clerk's Department.
