# By-law to dedicate certain lands in the Town of Amherstburg as a Public Highway (widening of Thrasher Drive)

**WHEREAS** the Municipal Act, R.S.O. 2001, c.25 Sections 24-68 authorizes the Council of every municipality to pass a by-law for establishing, laying out, acquiring, assuming, or naming a highway;

**AND WHEREAS** land has been transferred to the Town to be dedicated as a public highway for the widening of Thrasher Drive and it is now appropriate to dedicate Parts 2, 3 and 5 on 12R-29451 as follows:

 75 square metres

 12R-29451, Part 3
 75 square metres

 12R-29451, Part 5
 93 square metres

**NOW THEREFORE** the Council of the Corporation of the Town of Amherstburg enacts as follows:

- 1. THAT the lands described as Part 2, 12R-29451 with a size of area of 75 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby dedicated as a public highway, and forms part of Thrasher Drive.
- 2. THAT the lands described as Part 3, 12R-29451 with a size of area of 75 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby dedicated as a public highway, and forms part of Thrasher Drive.
- 3. THAT the lands described as Part 5, 12R-29451 with a size of area of 93 square metres in the Town of Amherstburg, County of Essex, Province of Ontario is hereby dedicated as a public highway, and forms part of Thrasher Drive.
- 4. THAT this By-law shall come into force and take effect immediately upon the final passing thereof at which time all by-laws that are inconsistent with the provisions of this by-law and the same are hereby amended insofar as it is necessary to give effect to the provisions of this by-law.
