1. **RECOMMENDATION:**

It is recommended that:

- 1. The report from the Joint Police Advisory Committee **BE RECEIVED**;
- 2. Administration **BE DIRECTED** to engage the services of MPM consulting to assist the Joint Police Advisory Committee in moving forward the Police Costing and/or Police Amalgamations for Council's future consideration;
- The Mayor & Clerk BE AUTHORIZED to sign the agreement with MPM Consulting; and,
- 4. The Joint Police Advisory Committee **BE DIRECTED** to do all of the following:
 - a. Develop an RFP for costing for Windsor and LaSalle to respond to
 - Explore and analyze the possibility of amalgamation of police services with LaSalle and/or Windsor
 - c. Work with the OPP on the OPP Costing
 - d. Report back to Council with the Joint Police Advisory Committee findings and recommendations.

2. BACKGROUND:

On Monday January 16, 2016, the Joint Police Advisory Committee (JPAC) met to review the proposal and qualifications of MPM Consulting to assist the Town in moving forward on the costing initiative for policing in the Town of Amherstburg. At the meeting the committee adopted the following motion:

Motion # 1

Moved by Jason Lavigne Seconded by Shawn McCurdy

"That:

- 1. The MPM Consulting Proposal BE RECEIVED; and,
- 2. A committee report be brought to Council recommending the Police Service Delivery consultation services of MPM consulting."

Motion # 2

Moved by Shawn McCurdy Seconded by Rick Fryer

"That the committee report include the possibility of amalgamation with local municipalities, LaSalle and/or Windsor."

3. <u>DISCUSSION</u>:

Included in the private and confidential memo provided to Council is the proposal and cost associated with the MPM proposal. On December 15, 2014, Council adopted the following motion:

"That:

- Administration BE DIRECTED to contact the OPP to obtain police costing for our municipality;
- 2) Administration BE DIRECTED to send correspondence to surrounding municipalities to see if there is interest in shared police services."

In response to the motion adopted by Council, the Town of La Salle responded on February 1, 2016 and advised that on January 26, 2016, La Salle Town Council unanimously adopted the following motion:

32/16 That an offer to provide policing costs by the Town of LaSalle to the Town of Amherstburg **BE EXTENDED** to the Town of Amherstburg. (see attached letter).

A letter was sent by the CAO on February 27, 2015 to the City of Windsor and the Town of LaSalle. In the letter received by the City of Windsor dated March 2, 2015, the City of Windsor expressed an interest in exploring a shared police service (see attached letter).

As can be seen from the responses, LaSalle is interested in providing a costing or fee for service and not sharing Police services. Windsor is willing to explore the shared

services option. Subsequent to the motion adopted by Council a moratorium was placed on all OPP costings. On February 2, 2016, the Province of Ontario provided notice to the Town that the moratorium on costing had been lifted and Amherstburg would be placed in sequence to receive a costing.

For Councils review the applicable areas of the Police Act are provided below:

Methods of providing municipal police services

- **5.** (1) A municipality's responsibility to provide police services shall be discharged in one of the following ways:
 - 1. The council may establish a police force, the members of which shall be appointed by the board under clause 31 (1) (a).
 - 2. The council may enter into an agreement under section 33 with one or more other councils to constitute a joint board and the joint board may appoint the members of a police force under clause 31 (1) (a).
 - 3. The council may enter into an agreement under section 6 with one or more other councils to amalgamate their police forces.
 - 4. The council may enter into an agreement under section 6.1 with the council of another municipality to have its police services provided by the board of the other municipality, on the conditions set out in the agreement, if the municipality that is to receive the police services is contiguous to the municipality that is to provide the police services or is contiguous to any other municipality that receives police services from the same municipality.
 - 5. The council may enter into an agreement under section 10, alone or jointly with one or more other councils, to have police services provided by the Ontario Provincial Police.
 - 6. With the Commission's approval, the council may adopt a different method of providing police services. 1997, c. 8, s. 4.

Same – different methods in one municipality

- (2) Subject to subsection (3), a municipality's responsibility to provide police services may be discharged in one way set out in subsection (1) in one discrete area of the municipality and in another way or ways set out in subsection (1) in other discrete areas of the municipality if,
 - (a) the municipality consists of two or more widely dispersed communities or contains, within its boundaries, one or more communities that are remote from the rest of the municipality; or
 - (b) police services have historically been provided to one or more discrete areas of the municipality in a way that is different from the way police services are provided in the rest of the municipality. 2001, c. 11, s. 1.

One board or joint board

(3) All the police services provided in one municipality, except police services provided in a way described in paragraph 3 or 4 of subsection (1) or police services provided in the municipality by the Ontario Provincial Police under section 5.1, must be provided under one board or joint board. 2002, c. 18, Sched. N, s. 59.

In light of the responses received from all services and the complexity of this issue, the Committee believes it to be prudent to engage the services of MPM Consulting to guide the Joint Police Advisory Committee through the process.

4. RISK ANALYSIS:

Should Council decide to move forward with the elimination for of the Municipal Police Service through a fee for service (costing model), it should be noted that municipal control of police will not be directed at the municipal level. The Town would no longer be a voting member of the police board and would be a pay for service relationship. The service will be governed by a contract which will establish the level of service and the parameters in which the service will be provided. This may result in a loss of municipal control which may present an element of political risk.

5. FINANCIAL MATTERS:

At present, it is unknown what the costs of the various models will have on the municipality. The costs associated in the proposal from MPM will be funded through the CAO operating budget for professional fees and services.

6. **CONSULTATIONS**:

JPAC committee members were consulted on the MPM Consulting proposal.

7. CONCLUSION:

That the municipality retain the services of MPM Consulting to assist the Joint Police Advisory Committee moving forward in the Police Costing/Amalgamation process.



In response to your letter dated February 27, 2015 and pursuant to discussions we have had to date, the City of Windsor and the Windsor Police Service are interested in exploring a model of shared police services.

City Administration has been directed by Windsor City Council to review costing models and options to this end.
