**THE CORPORATION OF THE TOWN OF AMHERSTBURG**

**BY-LAW NO. 2017-32**

**By-law to Appoint a Fire Chief for the Amherstburg Fire Department**

---

**WHEREAS** the Council of the Corporation of the Town of Amherstburg is empowered by the Municipal Act, S.O. 2001, c. 25, and the Fire Protection and Prevention Act, 1997, S.O. 1997, c. 4, to appoint a Fire Chief;

**AND WHEREAS** the Council of the Corporation of the Town of Amherstburg deems it expedient to appoint a Fire Chief to enforce the provisions of the said Acts; and,

**NOW THEREFORE** the Council of The Corporation of the Town of Amherstburg enacts as follows:

1. That Robert Bruce Montone be hereby appointed as Chief of the Town of Amherstburg Fire Department, effective April 24, 2017.
2. That Robert Bruce Montone be authorized to enforce the provisions of any applicable Acts or legislation and any other By-laws within the Town of Amherstburg.
3. That he shall have all the powers and duties as defined in By-Law Number 2015-108 in respect to the Fire Chief duties.
4. That By-Law Number 2016-57 is hereby repealed effective April 24, 2017.
