UNFINISHED BUSINESS

1. Councillor Prue asked for an update with respect to Resolution # 20191015-497 (Boblo Island, north end development) and Resolution # 20200914-293 (Boblo Island, Idling By-law).

The Chief Adminstrative Officer advised that the Boblo Island report regarding the north end development is currently being finalized and it should be before Council at the May 10th, Regular Council Meeting. He further advised that he believes the developer is looking at bringing equipment in via a barge for the south end development.

NEW BUSINESS

 Councillor McArthur asked for an update with respect to timelines for the skate park and what the plans are for volleyball courts in light of the Fort Family Fun Centre closure.

The Chief Administrative Officer advised the renderings for the skate park will be available at the end of the month and the next step will be public consultation. He further advised that the new Director of Parks, Facilities, Recreation and Culture will address future plans with respect to volleyball courts.

2. Councillor Courtney asked what the format will look like for public consultation during the pandemic.

The Chief Administrative Officer advised that the Clerk is bringing a report forward with respect to public consultation options and it will include as many ways as possible to engage residents.

3. Councillor Courtney asked if it was possible to place picnic tables in appropriate areas throughout the Kings Navy Yard Park.

The Chief Administrative Officer advised that it is possible, and furthermore, he advised that there is potential grant funding opportunities becoming available to accommodate gathering in parks. He advised that he is looking to bring a report to the May 10th, Regular Council Meeting with respect to options for Council to consider with respect to the potential grant opportunities.

4. Councillor Prue advised that the resident who requested the speed monitor sign on Meloche Road is looking for an update.

The Manager of Roads and Fleet advised that there is a lot of request to place the speed monitor signs in various locations and he will ensure that Meloche Road is on the list.

The Mayor advised that he will follow up with the Police with respect to speed enforcement on Meloche Road.

5. Councillor Prue advised of cars parking on the streets for days on Boblo Island, and further, that Police have advised that a by-law would have to be in place in order to enforce no parking on the streets.

The Manager of Roads and Fleet advised that he will look at the Traffic By-law and speak with the Manager of Licencing and Enforcement with respect to a possible by-law.

6. Councillor Renaud advised of the name change of Fox Road to Concession 3 and asked when it is getting corrected to maintain the honour of the Fox brothers who are included on the Cenotaph.

The Mayor advised that the Director of Engineering and Public Works is actively working on that matter.
