**NOW THEREFORE THIS AGREEMENT WITNESSETH** that in consideration of the terms, covenants and conditions contained herein and in consideration of the sum of One Dollar (\$1.00) now paid by the Owner to the Town (the receipt, sufficiency and adequacy of which is acknowledged) the parties hereto covenant and agree one with the other as follows:

- 1.1 Conveyance of Road Allowances and Easements
  - (a) The Town agrees to convey to the Owners Part 37 on Plan 12R14574.
  - (b) The Owners agree to grant an easement to the Town over Part 37 on Plan 12R14574.
- 1.2 Successors and Assigns

This Agreement will enure to the benefit of and shall be binding upon the parties hereto and their respective successors and permitted assigns.
