THE CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 1999-06

A by-law to dedicate as part of the Town Highway System reserve blocks in various subdivisions.

WHEREAS under the terms of subdivision agreements relating to various subdivisions, reserve blocks, laid out as part of the street system in the subdivisions, were reserved by the developer, and were not to be accepted and dedicated by the Town of Amherstburg until all of the requirements of the developer had been met;

AND WHEREAS the developer has completed all of the servicing to which the reserve blocks herein referred to relate, those services have all been initially or finally accepted by the Town of Amherstburg, and the developer has requested that the reserve blocks be accepted and dedicated to remove any question of the rights of access by owners of lots in those serviced phases of the subdivision.

NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:
