Being a by-law to strike taxes from the Tax Roll



NOW THEREFORE THE COUNCIL OF THE CORPORATION OF THE TOWN OF AMHERSTBURG HEREBY ENACTS AS FOLLOWS:

1. The Treasurer is hereby authorized and instructed to strike from the Tax Roll those taxes set forth in Schedule "A" attached hereto and declared to be a part of this By-law.
2. This By-law shall take effect on the final date of passing thereof.
