#### CORPORATION OF THE TOWN OF AMHERSTBURG

BY-LAW NO. 2001-09

By-law imposing special annual drainage rates upon land in respect of which money is borrowed under the *Tile Drainage Act*.

**WHEREAS** owners of land in the municipality have applied to the council of the Corporation under the *Tile Drainage Act*, for loans for the purpose of constructing subsurface drainage works on such land;

**AND WHEREAS** the council has upon their application lent the owners the total sum of \$36,400.00 to be repaid with interest (8 percent) by means of rates hereinafter imposed:

**BE IT THEREFORE ENACTED,** by the council, that annual rates as set out in the Schedule "A" attached hereto are hereby imposed upon such land as described for a period of ten years, such rates to be levied and collected in the same manner as taxes.
